
## STATE OF THE PROBLEM

Music of senior secondary students of Udaipur city towards music with reference to some demographic variables.


FLOW CHART SHOWING SAMPLE DISTRIBUTION

### Total sample size (N) = 600


1. School wise distribution of sample




2. Locality wise distribution of sample




3. Gender wise distribution of sample
