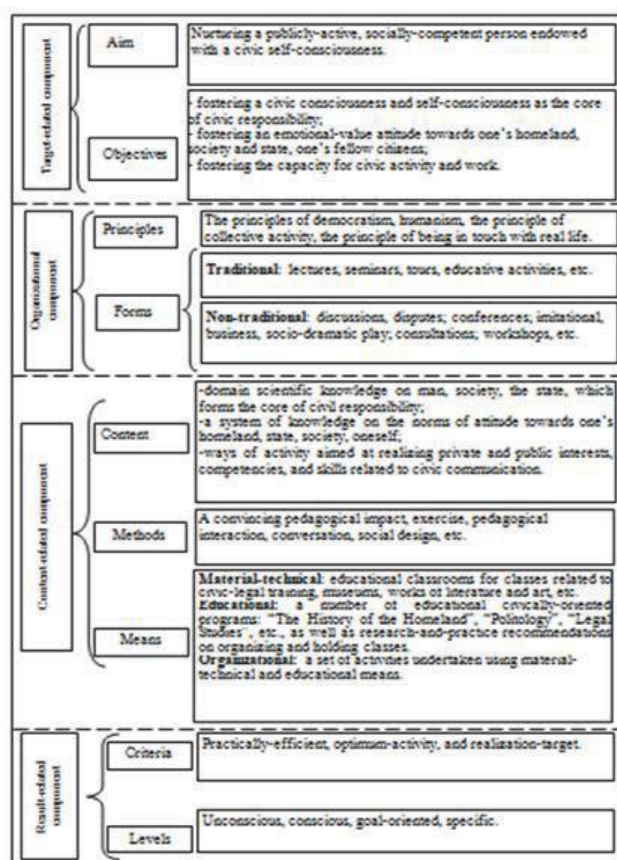


Figure 1. A model for the formation of a sense of civic responsibility in college students
