Present study is limited to parents of Ahmedabad. Total 250 parents were selected by using stratified random sampling method. Descriptive survey method was used to collect data by using self-prepared and standardized opinionative. Data was analyzed using Mean, Standard Deviation and t-test. Gender, Qualification and Profession were not affecting variables on the opinion of parents on International School Education.
